## VICE GOVERNOR OYO UY LAUNCHES ARAW NG PASASALAMAT, A CARAVAN OF SERVICES By: Jan Fhore Andrey Cagalitan



Delivering government services shall never be hampered by location's distance or remoteness. This is what Vice Governor Oyo Uy attested during the launching of Araw ng Pasasalamat on October 19, 2022 at Sitio Patel, Brgy. Gupitan, Kapalong, Davao del Norte.

Araw Pasasalamat ng "Thanksgiving Day" is a caravan of services in partnership with different personalities, government agencies, and non-government organizations. The program features six (6) services which include the following:

- 1. Free legal consultation at the grassroots level in partnership with Integrated Bar of the Philippines (IBP) Davao del Norte-Davao de Oro Chapter and St. Thomas More College of Law.
- 2. Free medical assistance (i.e. free check-ups/consultation and medicine) to the barangay residents in partnership with Rotary Club Tagum North, Philippine Pediatric Society - Davao Southern Mindanao Chapter, and Tagum City

Health Office.

- 3. Fast-track the disposition of untitled lots and processing of public land titles through residential and agricultural free patents for the identified beneficiaries ( Handog Titulo) in partnership with Department of Environment and Natural Resources, Land Registration Authority - Registry of Deeds, Provincial Environment and Natural Resources Office, and Provincial Assessor's Office.
- 4. Free registration to residents in order to equip them with health insurance coverage (Libreng Rehistro sa PhilHealth) in partnership with PhilHealth. This service was offered during the second and third round of Araw ng Pasasalamat.
- 5. Free haircuts to those who wish to avail of the program and defray the cost of extra expenses whenever they need to go out of their community just to cut their hair brought by former Ex-Officio Member - PCL President, Tristan Royce
  - "Bong" R. Aala.
- 6. Free porridge to event

participants brought about by some Board Members (BM Shirley Belen Aala, BM Tete So, BM Marianne Lu, and BM Popop Catalan).

Through the Vice Governor's Office, VG Oyo Uy aims to conduct this caravan of services once every month. The second round of Araw ng Pasasalamat was held on November 23, 2022 at Brgy. Sta. Fe, New Corella, Davao del Norte. While the third round was held on December 7, 2022 at Brgy. Maniki, Kapalong, Davao del Norte.

The one-day event highlights the importance of bringing social services programs to remote communities while putting emphasis on the value of gratitude or thanksgiving (hence, the pasasalamat).

Niadtong Nobyembre 21, 2022 pinaagi sa 21st Regular Session, naaprobahan na sa ikatulo ug pinal nga pagbasa sa Sangguniang Panlalawigan ang Provincial Ordinance No. 2022-013. Dako ang paglaom ni BM Nickel nga tungod sa maong balaodnon, mas mapahugtan ug magmalambuon ang mga programa ug proyekto para sa tanan nga PWD sa probinsyasa Davao del Norte.





#### The Revised Gender and Development (GAD) Code of the Province of Davao del Norte (Provincial Ordinance No. 2022-018) was passed for Third and Final Reading during the 23rd Regular Session of the Sangguniang Panlalawigan (SP) on December 5, 2022. Hon. Emerson Dave A. Silutan, LPT, Chairperson of the newly-created SP Committee on Gender Equality and Development and principal proponent of the legislation, staunchly advocated for the incorporation of provisions on substantial developments related to the plight of women, children, youth, lesbians, gays, bisexuals, transsexuals, queer, intersex, asexual ++ (LGBTQIA++s), senior citizens and persons with disabilities. The updating of the five (5) yearold GAD Code was likewise made possible with the technical assistance from the Provincial Gender and Development Focal Point System - Technical Working Group (GFPS-TWG).

The Ordinance provided a set of policies that spelled out the Province's goal of promoting an effective and gender-responsive development which also included comprehensive interventions for the practical and strategic gender needs of all Dabaonons. It further strengthened the advocacy on Gender and

## Gender and Development (GAD) Code Revision Paves Way For Enhancing Gender-Responsive Development

Development Awareness-Raising through the stipulations on the conduct of orientations for all schools, offices, establishments or companies, department and agencies including Provincial, City, Municipal and Barangay officials within Davao del Norte and Sangguniang Kabataan (SK) on gender sensitivity and equipping them with theoretical and practical knowledge on gender issues and concerns. Further, schools and concerned agencies within the Province of Davao del Norte are tasked to enhance and promote a curriculum that incorporates GAD concepts such as but not limited to understanding and awareness of Sexual Orientation, Gender Identity and Expression, and Sex Characteristics (SOGIESC), whilst utilizing Gender Inclusive and Sensitive Teaching Approaches and eradicating genderstereotyping and bullying. Further, a Monitoring, Evaluation and Reporting System shall be established to ensure progress in the implementation of GAD policies and render close monitoring and reporting of any gender stereotyped portrayals in any learning reading materials.

In the economic aspect, the formulation of Workforce Development Plan (WDP) for women is also a new inclusion thereto. Due focus is also given to skills development, employment, loan and investment programs, labor force participation for women, safety in the workplace and social protection. A recent addition to the Code include Overseas Contract Workers (OCW) Support for survivors of abuses, and provide special support to them including financial assistance to distressed Overseas Filipino Workers (OFWs) which could be utilized as a start-up or additional capital worth.

Additional provisions in the Code also include the enhancement of the Violence Against Women & their Children (VAWC) Desk in accordance with Republic Act No. 9710, or the Magna Carta for Women (MCW) and Republic Act No. 11313, or the Safe Spaces Act, through the establishment of Anti-Sexual Harassment (ASH) Desks and incorporating the latter to the VAWC Desk.

The revised Code provided clear stipulations on the implementation of a standard design to public and private buildings (e.g., comfort rooms) with accessibility features such as but not limited to handrails at entrance/exit, special lift/elevator, wheelchair accessible toilets with grab bars, and with appropriate turning space (non-skid flooring and signages) for the benefit of Persons with Disabilities (PWDs) as well as Senior Citizens. It also provided for the establishment of Teen Hub/Adolescent Friendly Health Facilities.

debonair bachelor is a father to his lovely daughter Leann Ember J. Catalan, whom he considers his pride and joy. He is the eldest son of Former Board Member Roy J. Catalan and Mrs. Leticia Agunod-Catalan, a retired Public School Teacher, and a grandson of the late Ponciano Bustamante Catalan, a Retired Colonel and former Provincial and Municipal Chief of Police, and Nenita Jaboc Catalan, a businesswoman, and also a grandson of Floro Agunod, a businessman, and Purificacion Vedijo Agunod, also a retired Public School Teacher. This is how the name FLOPONE ROYLE was uniquely combined.

At the young age of 18, Hon. FLOPONE ROYLE AGUNOD CATALAN, popularly known as POPOP CATALAN jumpstarted his political career as Barangay Kagawad of Barangay San Pedro, Panabo City, the youngest in the roster of Barangay Kagawads of the City, and served the people of his barangay for three terms.

The passion to serve the people has been genuinely rooted in the blood as he and his siblings Mark Ceasar, an accountancy graduate who handles the family business, Hon. Ian Rolet Catalan, now City Councilor of Panabo City, and Maria Nova, a Registered Medical Technologist and is now taking up Medicine, grew up seeing their father Roy Catalan poured out his life to public service for over three decades. As a young boy, Popop became one of the Ten Outstanding Boy Scouts of the Philippines in 2005 and the Little City Mayor of Panabo during the Linggo ng Kabataan celebration sometime in 2004.

He graduated from Bachelor of Arts in Political Science at the Ateneo de Davao University and finished his post graduate studies of Bachelor of Laws at the University of Mindanao College of Law. The dream to become a fullfledged lawyer has been kept sometime because God had another plan for him as he was called to serve the Panaboans when elected as one of the Sangguniang Panlungsod Members in the City of Panabo in the May 2016 Elections which eventually sat him to a two-term journey when reelected in the same position in May 2019.

Being held in a higher form of public service, the young Catalan was greatly challenged to create his own set of footprints without sacrificing the image and sanctity inscribed by his father RJC, being a parliamentary champion of his times. True to his mandate, Popop became an effective legislator of the City as he authored several remarkable legislations that benefited the underprivileged and vulnerable sectors of the locality. Some of his noteworthy legislations include the Establishment of the Person with Disability Affairs Office, Establishment of the Office of the Senior Citizens Affairs, Granting of Honorarium to the Senior Citizen, PWD and Solo Parent

Born on October 30, 1988, the dashing and Coordinators in the Forty Barangays of the City, the Centenarian Ordinance, the Establishment of the Association of Senior Citizens, PWD and Solo Parents, the Institutionalization of the Sulong Dunong Educational Assistance Program in the City, and the enactment of the Solo Parent Ordinance which grants additional benefits to the solo parents and their children at the local level.

The turn of events in his political venture unexpectedly came when called to run for office as Sangguniang Panlalawigan Member of District 2 in Davao del Norte last May 2022 Elections. He recalled the experience as overwhelming and at the same time very challenging.

BATAN-ONG MASALIGAN became his trademark, a reliable, copper-bottomed young man, which Popop proved through his various legislations in Panabo City. Unsurprisingly, because of his natural charm and achievements, he easily captured the hearts of the people of the 2nd District of the Province of Davao del Norte and landed as the youngest elected Senior Board Member of Davao del Norte at the age of 33.

Fate as it was, POPOP CATALAN was proclaimed Senior Board Member in the entire Province of Davao del Norte, garnering an overwhelming votes of 146,840 which makes a mark in the history as the youngest elected Senior Board Member to date in the Province. He humbly affords the credits for this success to

the Almighty God, to the legacy built by his father RJC in public service and to the people of Davao del Norte. He believed that it is both fate and the faith of the people which led his destiny to a higher form of humanitarian service.

Popop Catalan embodies both a good politician and public servant as he vows to become a productive Board Member of Davao del Norte where he presently holds the

Committee on Laws, Committee on Ways and Means, and the Committee on Social Services.

On his privilege speech during the 2nd Regular session of the Sangguniang Panlalawigan (Term 2022-2025) last July 11 2022, it has been recalled that the young Senior Board Member cited a quote from his former professor in Law School, Jesus Melchor "I HAVE NO Quitain, FRIENDS TO SERVE, I HAVE NO ENEMIES TO HARM." He stressed that the essence of a public servant's mandate is to set aside one's


