## Vice Governor Rey T. Uy Wears No Cape

We are almost through with 2021 having three months left, but we still struggle a lot because of the COVID-19 pandemic. However, despite our situation, we still have silver linings that save us from distress. One of these silver linings is Vice Governor Rey T. Uy who wears no cape in serving the Dabaonon people. He provides hope to our people as he continues to deliver the requests of the people of Davao del Norte. Together with various government agencies and offices, numerous programs and projects are funded to reach our displaced workers, out-of-school fellowmen, financially struggling college students and those who got positive for COVID-19 disease. These initiatives are not solely because of the Office of Vice Governor Rey T. Uy, but Vice Governor plays a vital role in assisting and identifying the qualified recipients.

Vice Governor Uy was instrumental in the provision and distribution of three hundred (300) sacks of cement to some schools and residential houses in the localities of Davao del Norte. Eight (8) differently abled and senior citizen individuals were also grateful for the wheelchairs wholeheartedly given to them. Handheld radios, sphygmomanometer blood or pressure monitor, lapel with microphone, and refrigerators are among the supplies and items requested by the different barangays Uy hopes that these could alleviate in Davao del Norte which he acceded their pain and suffering.

to as he believes in the wide array of benefits these could offer to the people.

From the month of July to August, four programs implemented, and one initiative is continued. With the help and funding from the Commission on Higher Education (CHED), Department of Labor and Employment (DOLE), and the Technical Education and Skills Development Authority (TESDA), Vice Governor Uy was able push through with his vision to aid and uplift the lives of the people in our province. His office commences the Duyog sa Pagtulog Program which distributes pillows to every household. This program aims to provide comfort to our hardworking fellow Dabaonons who work unceasingly for their family's future and needs. Currently, his office has already dispensed 500 pillows province-wide.

Moreover, the distribution of groceries continues as 524 families received food packages with hygiene kits in just two months. These packages and kits were provided to families who were facing varied and difficult life situations, specifically those who have suffered economic pain due to loss of jobs or income brought about by COVID-19 while some needed assistance during the wake of a loved one. These packages may not be much but Vice Governor

Being one of his top priorities, Vice Governor Rey T. Uy envisions empowering the citizens through quality education. With this, he immediately accepted the offer of CHED to be a partner in the implementation of the Tulong Dunong Scholarship Program that provides financial assistance to college students. With this program, 150 scholars will receive Fifteen Thousand Pesos (Php 15,000) yearly or Seven Thousand Five Hundred Pesos (Php 7,500) every semester until they graduate.

Furthermore, the Office of the Vice Governor also facilitates in filling 140 slots intended for Overseas Filipino Workers (OFWs), terminated workers due to the pandemic, and citizens belonging to the marginalized sector of the society for skills training to be provided by TESDA. There are three (3) courses being offered by TESDA in partnership with Sto. Niño Agricultural and Machinery Technical Institute, Inc., namely Forklift, Hydraulic Excavator, and Shielded Metal Arc Welding. The said skills training will be availed for free by the trainees who will also be receiving allowances and insurance benefits.

Another laudable program which the Office of the Vice Governor helps in its successful implementation in collaboration with DOLE is the Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD). cont. to page 2

## **HEALTH OF THE DABAONON PEOPLE: A PRIORITY TO SP DAVNOR**

In this time of national health emergency brought by the pandemic Coronavirus Disease 2019 (COVID-19), the Sangguniang Panlalawigan (SP) of Davao del Norte continuously upholds the betterment of the Dabaonon people in grappling with the challenges especially in the health sector through the pieces of legislation passed by the esteemed legislative body. The Sangguniang Panlalawigan's support to the K.U.Y.A.G.O.B. Development Agenda, especially its Universal Health and Social Services, can be gleaned from the approval of Resolution No. 579, series of 2021 relative to the renewal of the monthly fund support allocation for the healthcare program of the disadvantaged and marginalized constituents in Davao del Norte Hospitals: DDN-Kapalong Zone, Two Million Pesos (P2,000,000.00); DDN-Carmen Zone, One Million Pesos (P1,000,000.00); and DDN-Samal Zone, One Million Pesos (P1,000,000.00)".

As it was certified as urgent by the Honorable Governor, Mr. Jeffrey R. Calamungay, the Provincial Government Assistant Department Head of the Provincial Social Welfare and Development Office (PSWDO), shed light on the said measure as he discussed that this Malasakit Program is sourced out from the Office of the President Socio-Civic Project

Fund. He expounded that its implementation is now on its third cycle after its second cycle which was administered last March 2020 up to June 2021 that has served 31,052 clients in all the three Davao del Norte Hospitals (Kapalong Zone, Carmen Zone and Samal Zone), utilizing a total amount of P38,539,249.25. He then enumerated that for the second cycle of the Malasakit Program, Kapalong Zone, Carmen Zone and Samal Zone has catered 14,665 patients, 6,618 patients and 9,769 patients, respectively. Furthermore, he explained that for the establishment of Malasakit Centers in all of the three (3) hospitals of Davao del Norte, Kapalong Zone has a monthly allocation of P2,000,000.00 and Carmen Zone as well as Samal Zone has a monthly allocation of P1,000,000.00 each. Thus, he said that the Office of the President Socio-Civic Project Fund will be allocating a total amount of P4,000,000.00 every month for the purpose; hence, their request for the urgent passage of a resolution relative thereto.

Meanwhile, in the pursuit of the legislative department to ensure the wellness of the Dabaonon people, Dr. Alfredo A. Lacerona, MD, Provincial Health Officer II and Incident Commander of the COVID-19 Provincial Task Force, was invited during the SP's 31st Regular Session last August 2, 2021 and has apprised the August Body on the updates of the COVID-19 Delta variant which was reported to be already present in the province as he rendered a presentation, to quote:

"... Now, with regard to our COVID updates, as of now, we have already reduced the cases comparing from the month of June but, unfortunately, murag wala gyud sya nagbaba into a safe level. Naa gihapon ta sa mura og not in critical level but still in the highrisk level. The daily positive rates nato [is] below one hundred (100) na sya but our hospital bed capacity is enough lang gyud para sa ani nga level. The worry of all the health personnel is kaning atong new Delta variant which is already here in our province. Naa tay isa nga na-identify but the problem [is] ang atoang Department of Health (DOH) is late sila mu-report because of the limited slots sa atoang genome sequencing. Late sila for fourteen (14) to twentyone (21) days. Gani ang atoang identified nga Delta

variant is already considered cleared and is now working, gatrabaho na siya, and sa iyahang mga F1, naa puy nag-positive, considered cleared na po... I think we can prevent transmission sa atoang Delta variant kay hangtod karon ang problema lang gyud nato is the enforcement especially sa atong mga crowded areas kay wa may kalahian, same gihapon ang transmission sa atoang Delta variant. Kana lang kay mas infectious sya, sixty percent (60%) more infectious than the UK variant or sa kadtong atoang Alpha variant kay daghan kaayo og viral load ang individuals who are infected with the Delta variant... So, sa trend sir, naa tay weekly trend from January; now, makita gyud nato dinha nga last June, didto gyud nag-peak ang atoang positive COVID cases. Now, after sa declaration sa atoang MECQ, saka pod naay drastic downward sa atoang trend. So, nagbaba gyud ang atoang cases but unfortunately, pag-revert na pod back to GCQ, nag-relax na pod ta gamay, didto naay slight increase o nag-plateau na sya for three (3) weeks. So, hopefully dili ni sya magpadayon, hopefully magbaba pa gyud ni sya during this GCQ. So, again, gina-remind na lang pod nato ang atong mga LGUs nga i-strict lang gyud ang enforcement sa atong mga guidelines... Now, for the isolation update, daghan na gyud kaayo'g available kay, as I've said, ang mga positive cases karon are already naa na sa ilahang mga households for strict monitoring... Now, for the COVID-19 Delta variant, kung i-compare nato sya with the other variants—sa Alpha, Beta and Delta—so, ang atoang Alpha man gud is una na-identify sya sa United Kingdom (UK), so mao na sya ang UK variant and ang Beta is na-identify sa South Africa and ang Delta [is] first na-identify sya sa India. As of now, ang atong Alpha is naa na sa mga one hundred seventy-two (172) countries and Beta [is] two hundred twenty (220) countries and ang atong Delta, kani sya nga data is last June, naa na sya sa mga one hundred four (104) countries. And most of the countries nga nag-surge o naay surge this time, ang dominant strain is already the Delta strain. Now, ang ilahang pagka-contagious, kani si Alpha, the UK is fifty percent (50%) more contagious than the original, katong sa Wuhan, and Beta, mao gihapon, contagious gihapon ni sya but kani si Delta is fifty to sixty percent (50-60%) more contagious

sya than the UK. So, paspas na gani si UK, mas paspas pa gyud si Delta compared to UK. So, sa karon nakita nila nga mas paspas si Delta because paspas sya mag-multiply, mas daghan og viral load ang individual nga infected with the Delta variant. So, comparing with the Alpha, sa UK, nga ang one (1) positive individual with Alpha maka-infect lang sya'g one (1) to two (2) individuals; but for the Delta, muabot syag six (6) to eight (8) individuals ang pwede niya matakdan. And again, mas resistant o dili ing-ana ka-effective ang kaning atoang o nagreduce ang effectivity sa mga vaccines pag-abot sa Delta variant... mas nakakahawa gyud si Delta and same, mas the better nga maprotektahan ta with the vaccines sa Delta. So, almost all of the vaccines gihapon naa gyud syay protection, lesser lang ang effectivity nato sa Delta... So, ang importante is naa na ta dinhi karon na-identify sa Davao del Norte, taga Tagum... Now, because of the new Delta variant in our Province, the DOH recommended nga dapat i-locate dayon nato ang positive, kadto

si Delta; so, it is already located, contact-traced... Now, regarding sa vaccine, because ang atoang the best prevention ani is una ang katong atoang basic health protocols—kadto si Iwas, Hugas ug atoang Mask—plus kaning atoang vaccination but unfortunately, until now, limited gihapon ang atoang allocation sa vaccines. So, for the whole province, we have a target [of] seventy percent (70%) of our population. Dapat naa tay seven hundred forty-four thousand four hundred five (744,405) nga atong mabakunahan para maabot nato ang atong herd immunity, that is seventy percent (70%) of our population in the province... Comparing pod sa uban, murag mas lamang ta ani sa atong accomplishment kay na-comply gyud nato; pag muingon sila'g hurot dapat by the end of the week, hurot gyud pud nato og bakuna bisan pa'g nagkagubot na sa gawas. So, until now, mao lang gihapon, nagadepende lang ta sa allocation sa DOH with regard sa atoang vaccines. Now, lastly, ang atoa pong Quick Response (QR) Code

System, kaning atoang ginatawag nga Davao del Norte Contact Tracing System nato, ato ng ginausab karon kay nag-upgrade naman ta. Ato ng gi-incorporate ang atoang vaccination status. So, karon kung updated na, ang problema lang is naa lang tay problema karon sa system because sa globe nato nga net, murag nag-down. So, once nga i-scan ta, dili lang ta makita didto sa scanned nga good/allowed to access but makita nato ang atoang vaccination status. So, ma-identify na pod kung naka-first dose ka or naka-second dose ka; so, mao nay advantage sa atoa. I think, una pod ta nga naka-develop ani. In fact, ang atoang mga malls here in Tagum City, they have already provided incentives sa kadtong maka-vaccinate na. So, dili na sila maglisod og pangita o verify kung vaccinado na ba ta o dili, diri na lang sa atoang QR Code System. Pag-scan ana, mugawas na pod didto kung naka-first dose ba ka or naka-second dose na ka, including kung unsa nga vaccine ang imohang na-

## BM JANNET TANONG-MABOLOC SUPPORTS SOLO PARENTS, PASSES RESOLUTION NO. 642

Being the Chairperson of the Committee on Women. Children & Family Relations of the Sangguniang Panlalawigan of Davao del Norte. 2nd District Board Member Jannet Tanong-Maboloc asserted that "single parents, like senior citizens and persons with disability, must also be given utmost priority for they too have special needs and that they are entitled to the programs, services, privileges and benefits from the government." For this reason, she sponsored Resolution No. 642, s-2021 to support the cause of the solo parents, first in Panabo City, then subsequently in the entire province. Under this measure, all solo parents registered in the City Social Welfare and Development Office in Panabo City are entitled to the benefits and privileges provided in the ordinance, it also enhances the educational assistance through scholarship programs, housing benefits and medical assistance even death and burial assistance.

BM Tanong-Maboloc asserted that the approved resolution is based on Republic Act No. 8972, otherwise known as "The Solo Parents' Welfare Act of 2020," an Act Providing for Benefits and Privileges to Solo Parents and Their Children, Appropriating Funds Therefor and for Other Purposes." The said RA 8972 declares the policy of the State to promote the family as the foundation

of the nation, strengthen its solidarity and ensure its total development, as the State commits to the development of a comprehensive program of services for solo parents and their children.

Being a mother of two, she strongly believes that the rearing of a child for civic efficiency is the duty of every parent, it is then proper that parents, more so a solo parent, should be given preferential attention by lobbying full support and aid from the government. It must be taken notice that the promotion of family is the foundation of good governance. "Being a parent is a challenging role, parenting is probably the most difficult incline we must climb without absolute training, more so being a single parent wherein there is no partner to share the labor, the joys and the tears that parenting would bring." BM Tanong-Maboloc said during a sideline interview after the approval of the measure.

For BM Tanong-Maboloc, "single parents have the toughest job in the world. They single-handedly wrestle the trials of rearing a child and providing for their financial needs. Sometimes, they often feel left alone with no one to take care of them when they need help, and they also face the stigmas associated with being a solo parent, not only for themselves but also to their little ones."

# BM DRA. LU SCORES DRUG FREE & HEALTH AND NUTRITION ORDINANCES

The Committee on Health and Social Services, through the Chairpersonship of Hon. Denise Marianne A. Lu, MD, sponsored City Ordinance No. 902, s-2021 and City Ordinance No. 927, s-2021 of the City of the Tagum to show support in the city's drive to promote the general welfare of the inhabitants of the city last July 19, 2021 and August 9, 2021, respectively.

The City Government of acknowledges the threat and ill-effects brought about by illegal drugs on the community and workplace. In its declaration of policy, the City Government declares to absolutely prohibit the use of dangerous drugs in and outside the office by all officials, employees including the twenty-three (23) barangays without distinction as to work, employment status or salaries and shall cover all stages of employment. The City Ordinance No. 902, s-2021, entitled "an ordinance establishing a drug-free workplace in all barangays of Tagum City, providing funds therefor and sanctions for violations thereof ", was approved for Third and Final Reading. In her sponsorship speech, Dr. Lu emphasized that "the subject ordinance embodies the provisions of Republic Act No. 9165 and other pertinent laws which require that there will be a random drug testing in all workplaces anent thereto it is in harmony with the Provincial Ordinance No. 2021-002, also known as the "Drug-Free Government Workplace Ordinance of Davao del Norte." The Province of Davao del Norte provides a roadmap for both the provincial

government, the cities and municipalities of the province towards a comprehensive anti-illegal drugs strategy for both the public officials and employees, as well as for the private business establishments like contractors, suppliers or concessionaires. Hence, all Local Chief Executives are mandated to cooperate to curb illegal drugs in their respective LGUs.

Meanwhile, the Committee on Health has also seen City Ordinance No. 927, s-2021 with high regard, entitled: "An ordinance enabling the health and nutrition for the first 1,000 days of life through a reinforced and unified approach for maternal, newborn and child health and appropriating funds therefor and for other purposes." It aims to provide a comprehensive, sustainable, multi-sectoral strategy to address health and nutrition problems of newborns, infants and young children, pregnant and lactating women and adolescent females' particularly wasting and stunting malnutrition particularly among infants and young children from zero to two years old, adolescent girls, pregnant and lactating women in the City of Tagum. The Provincial Health Office released the LGU Scorecards on Health for 2019-2020, a component tool of the monitoring and evaluation for equity and effectiveness, which monitors the progress of health reform implementation at the local level. The accomplishments of every local government unit were presented for appreciation which contributed in attaining Health-Related Sustainable Development Goals



of the province. Tagum City led in terms of increased LGU Investment for Health marking 21.49% as total city budget allocated to health, nutrition, and environment for 2020 only a little less than the National Average in 2020 at 22%.

With the approval of City Ordinance No. 927, s-2021, Dr. Lu is optimistic that what she and her late husband's vision in proactive legislation towards the health sector is one by one being achieved through the support of the members of the August Body. They share the same plight, and that is to urge local chief executives in each city and municipality to consider health as a priority and accept it as a fact that the health of the constituents is an ultimate responsibility. As Dr. Lu once said, "we will support every effort made towards our goal in securing a better health to every Dabawnon."

At the end of the day, it all comes to this, the health of our constituents is the wealth of our province."


