BM DR. LU INDORSES DAVNOR'S PRO-POOR HEALTH & SOCIAL SERVICES PROGRAMS By: Keeper Genota

Dr. Denise Marianne A. Lu has been actively raising health awareness by visiting every Barangay in District II of the Province of Davao del Norte, specifically in its Barangay Health Centers, to talk about how to maintain good health among the constituents and to donate medical implements such as sphygmomanometer, glucometer and nebulizer in hopes of providing easy access of these health devices to every Dabaonons, aiding the collective effort of the government to overcome the challenges in the health sector.

The Department of Health reported that the leading causes of death in the Philippines remain to be diseases of the heart, diseases of the vascular system, pneumonias, malignant neoplasms/ cancers, all forms of tuberculosis, accidents, COPD and allied conditions, diabetes mellitus, nephritis/nephritic syndrome and other diseases of respiratory system. Among these diseases, six are non-communicable and four are the major NCDs such as Cardiovascular Diseases, cancers, Chronic Obstructive Pulmonary Diseases, and diabetes mellitus.

"It is necessary that these monitoring devices are readily available in barangay health centers so that our people will have an easy access to them, they need not go to hospitals, they can just easily monitor their health status with the help of our barangay health workers," according to Dr. Lu referring to the health measuring

devices she provided in every barangay. "Most common diseases and leading causes of death in the Philippines can be prevented by having a healthy lifestyle and constant monitoring of our health status," she quipped.

Sphygmomanometer is a device used for measuring blood pressure while a glucometer is a small, portable device that can check blood sugars (glucose levels). On the other hand, a nebulizer is a drug delivery device used to administer medication in the form of a mist inhaled into the lungs. Nebulizers are commonly used for the treatment of asthma, cystic fibrosis, COPD and other respiratory diseases or disorders. Dr. Lu hopes that these health devices will be put in good use for the benefit of all Dabaonons.

Being the Chairperson of the Committee on Health and Social Services, Board Member Denise Marianne Lu, MD implements sponsored Α Municipal Ordinance No. 299-s-2021 institutionalizing the "Punerarya sa Masa" Program of the Municipality of Carmen which was approved on January 24, 2022 during the 4th Regular Session of the Sangguniang Panlalawigan. This first-class municipality in the 2nd Congressional District of Davao del Norte, whose source of income is predominantly agricultural, is perceived to have a considerable number of impoverished families. The present financial predicament are results of loss of job, and lack of opportunities aggravated

by the COVID-19 pandemic.

Through her initiatives, LGU Carmen had put in place a variety of programs and projects ranging from livelihood to health and then other essential services such as funeral and burial services. The pauper's burial program aims to alleviate the plight over the loss of a family member. It shall include provision of coffin, the proper care and transport of cadaver up to its entombment. Municipal Ordinance No. 299-s-2021 established a section or office, under the direct supervision of the Municipal Social Welfare and Development Office, that maintains the administrative works, accounts and records of the program. The MSWDO has assigned personnel to oversee and manage its smooth implementation.

The municipality allocated and provided an initial annual budget in the amount of Five Hundred Thousand pesos (P500,000.00) for the embalming, coffin and transportation of the cadaver and also for the Maintenance and Other Operating Expenses (MOOE) of the section/office. "Kailangan barugan kay dako kaayong tabang sa atong mga katawhan. Dili na angay maguol pa ang namatyan kay nahan-ay na ang tanan para sa minatay. Hon. Silutan Intensifies the Conduct of KK Assembly Days in all DavNor Barangays through Provincial Ordinance No. 2022-002

The Committee on Youth and Sports Development chaired by the SK Provincial Federation President & Ex-Officio Sangguniang Panlalawigan Member Hon. Emerson Dave A. Silutan conducted a series of virtual public hearings last March 21-22, 2022 together with the DILG Davao del Norte Local Government Operations Officer II Sir Marc Voltaire Daquigan, Provincial Sports and Youth Development Office PG Department Head Sir Giovanni I. Gulanes, Provincial Sports and Youth Development Office Youth Development Officer Sir. Jay Michael Fernandez, and SK Chairpersons of the eight (8) municipalities and three (3) cities of the Province of Davao del Norte. During the public hearings, all municipalities recommended favorably the Provincial Ordinance No. 2022-002 "Declaring the Saturdays and Sundays of June and December of every year as Katipunan ng Kabataan (KK) Assembly Days in all Barangays of the Province."

For over three years length of service of Sangguniang Kabataan in the province, Hon. Silutan observed that there are two major issues on the conduct of Katipunan ng Kabataan (KK) General Assembly Meeting: firstly, many barangays are not strictly implementing this mandate which is a basic contrivance to delve the existing issues, concerns and proposals of the KK Members and secondly, no specific schedule is provided in the IRR of RA 10742 so the date and time of the KK Assembly Meeting is up on the prerogative of the respective SK Councils, leading some of them to conclude that such takes no necessity.

Cognizant of this provision, it is unequivocal that this mandate shapes a foundation of collegial forces and direct sharing of collective experiences, ideas and concerns of the Katipunan ng Kabataan (KK) Members which represent different sectors such as in-school youth, OSYs, LGBTQs, IP Youth, young parents and the like, toward a smooth and facilitative crafting, monitoring and assessing of various programs, projects and activities (PPAs) of the Sangguniang Kabataan in the barangays of the province and further ensure that these PPAs are relevant, responsive and impactful.

This Provincial Ordinance serves as an additional legal basis to strengthen the conduct of KK Assembly Days of every barangay in the province considering that SK Officials are mandated by law to do so.

Ang maong resolusyon hiniusang gi-aprobahan sa mga miyembro sa Hunta Probinsyal niadtong 15th Regular Session last Abril 11, 2022. Gikabutyag ni Board Member Roger "Ger" Laguna nga tumong ug tingoha niini nga mas hingpit nga mapatuman ug ma-implementar ang R.A. 11223 nga giilang Universal Health Care Act (UHCA). The HPU shall ensure the development and implementation of health promotion policies and programs and exercise coordination with local government and Hospital Health Promotion and Education Officers and Barangay Health Workers (BHWs) as barangay-level HEPOs." Kalakip na niini ang Section 468 of the Local Government Code nga nagpamatuod nga ang "Sangguniang Panlalawigan has the power to determine the position and salaries/wages/allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conducts of programs, projects, services, and activities of the provincial government. Gipalig-on pa ug gipalaluman ang basihan sa pag-aproba niini subay usab sa Akta Republika 11223 or the Universal Health Care Act and its Implementing Rules and Regulations.


