

VG Oyo Uy leads launching of eight additional Alagang Tingog Centers and AICS distribution

Alagang Tingog Centers (ATC), were successfully launched on April 19-21, 2023. A ribbon-cutting ceremony led by Vice Governor De Carlo "Oyo" Uy and House Deputy Secretary General "Ponyong" Sofonias Gabonada, Jr., representing House Speaker Ferdinand Martin Romualdez in the event, marked the official inauguration of the additional ATCs in the province. These ATCs, the brainchild of House Speaker Ferdinand Martin Romualdez and Tingog Partylist Rep. Yedda Marie Romualdez, will serve as a social service and public outreach center, providing burial and medical assistance to those who might need it.

Led by Vice Governor Oyo Uy as the Provincial Tingog Coordinator, DSWD. Tingog Partylist formally opened During the series of launching of an ATC each in Island Garden City ATCs and AICS payout, VG Oyo Uy of Samal, Panabo City, and in the municipality of Carmen on April 19, 2023. The following day, April 20, 2023, one ATC each was inaugurated in Tagum City and in the municipalities of San Isidro and Asuncion. While an ATC each in the municipalities of Braulio E. EIGHT additional Tingog Partylist was inaugurated on April 21, amid Satellite Offices, formally called the regular holiday throughout the the regular holiday throughout the country in observance of Eid'l Fitr (Feast of Ramadhan).

Following the inauguration rites, the ATCs commenced their operations along with the payout of financial assistance through the Assistance to Individuals/Families in Crisis Situations (AICS) program of the Department of Social Welfare and Development (DSWD). A total of 20 million pesos were allocated for the 10,000 beneficiaries receiving 2,000 pesos each.

The launching of the ATCs and the payout of financial assistance were spearheaded by the Vice Governor's Parallel to Tingog Patylist's Office and the 2nd Congressional mantra, VG Oyo Uy emphasized the District Office, together with the need to reach out to more people

During the series of launching of and Mr. Gabonada Jr. were joined by IGACOS Mayor Al David Uy, Panabo City Vice Mayor Banjong Dujali, Carmen Mayor Leony Bahague, Tagum City Mayor Rey T. Uy, Asuncion Mayor Yuri Dayaday, Braulio E. Dujali Mayor Tata Moral-Romano, and Sto. Tomas Mayor Roland Dejesica.

Before launching the additional ATCs, two ATCs located in the municipalities of Kapalong and New Corella were inaugurated last November 22, 2022. This makes a total of 10 ATCs in the province of Davao del Norte.

On the 17th Regular Session of the Sangguniang Panlalawigan (SP) of Davao del Norte for Calendar Year (CY) 2023, Term 2022 to 2025, held on April 24, 2023, SP warmly welcomed Dr. Reynaldo B. Mellorida, CESO V and Dr. Alona C. Uy, CESO V, both the new Schools Division Superintendents (SDS) of Davao del Norte and Tagum City Divisions of the Department of Education (DepEd), respectively, as they were invited to apprise the August Body about their respective plans and programs for the current academic year as well as the statistics pertaining to the enrollment data and the Learning Delivery Modalities utilized within their particular divisions.

Dr. Mellorida and Dr. Uy both established that the programs, plans and activities (PPAs) of their respective divisions are steadfastly anchored on the MATATAG Agenda of Vice President (VP), DepEd Secretary Sara Duterte-Carpio. As discussed during the question hour, the MATATAG Agenda is spelled out, as follows: "MA" is to MAke the curriculum relevant to the needs of the learners in order for them to produce competent, job-ready, active, and responsible citizens; the first "TA" is to TAke steps to accelerate the delivery of basic education services and provision of facilities; the next "TA" is to TAke care of the learners by promoting learner well-being, inclusive education, and a positive learning environment; and, "G" is to Give support for the teachers to teach better. These aim to reach DepEd's goal that all Filipinos will be able to realize their full potential and contribute meaningfully in building a cohesive nation. Moreover, through the MATATAG Agenda spearheaded by VP Sara Duterte-Carpio, it will help facilitate the learning recovery of the students from

the struggles and transition period on the various Learning Delivery Modalities that was introduced by DepEd for the past two years in coping up with the needs of time due to the surge of pandemic Coronavirus Disease 2019 (COVID-19).

Dr. Mellorida, when asked by one of the distinguished Members of the August Body if what are his priority programs in his division, answered that his top priority is to implement relevant curriculum mandated by the Department, so as to put everything in place especially those that are outlined in the MATATAG Agenda of Secretary Duterte-Carpio. He further replied that he also focuses on the provision of classrooms and school furniture to his division. Lastly, he said that he gives emphasis on the implementation of inclusive education to all the schools under his division, especially those who are deprived of educational services in the far-flung areas of the Province such as the Indigenous Peoples Education, the Madrasah Education, the Special Education (SpEd) Program, among others. "That's why it is my passion to, of course, provide a level playing field. What are provided in the urban areas should also be given to our students in the remote areas. Dapat pantay-pantay, dapat patas," SDS Mellorida ardently manifested during the interpellation period.

Also, Dr. Uy stressed out during her presentation that her division is looking into the Reading Recovery Program for their learners so that they will be able to improve their reading proficiency because as what she manifested, "reading actually is the basic thing that we must really consider for them to learn better." She further explained that it is the very reason why they have an ongoing reading

program in the City Division. Moreover, in accordance to the letter "G" of the MATATAG Agenda as defined above, she said that they have an ongoing capacity building activities for all their teachers and non-teaching personnel with the aim to upskill and reskill them. Furthermore, she said that they are also focusing into the infrastructure needs of their division since there are schools that need repair and rehabilitation. In line with that, she also expressed her heartfelt gratitude to the Honorable Mayor of Tagum City, Hon. Rey T. Uy, because they do not have to forward any solicitation anymore to their partner stakeholders due to the proactive initiatives of the City Mayor in augmenting chairs for the schools throughout the City through the Care for School Chairs Program. "So, some of those that we needed for our schoolchildren have been addressed already by the local government unit. I am forever grateful for that initiative of the Honorable Mayor of Tagum City," Dr. Uy joyfully expressed on the latter part of her presentation. On her speech, she also thanked everyone's support on the opening program of the Davao Regional Athletic Association (DAVRAA) 2023 held at Tagum City.

Additionally, both them of reported to comprehensively the Sangguniang Panlalawigan the detailed statistics pertaining to the enrollment and the Learning Delivery data Modalities utilized within their respective divisions during their appearance before the Honorable Chamber as well as the different issues and concerns for the implementation of their respective programs, projects and activities for CY 2023, and also shed light on the queries and clarifications of the legislators on the SP's 17th Regular Session. 🛓

Amit was a former Janitor at Coca-Cola, a construction worker at Santos Land, a Jeepney Conductor and a Lanchero (lantsa worker) who by fate turned to become the Private Secretary of the Former Davao del Norte Governor Prospero Amatong, the Executive Assistant for Political Affairs of Former Governor Rodolfo R. Del Rosario, a part-time instructor in Samal Institute handling the subjects on

Parliamentary Procedure and Argument & Debate, and a Board of Director in Planters Products and INC. in Mission Motivators Asia INC. Hon. Orly

A. Amit has clawed his way from the bottom-up. But surrendering to his inner desire and to the noble calling of public service, he has chosen the path of serving the people from all walks of life, starting from being a Barangay Councilor of Barangay Miranda to a three (3) consecutive terms as a City Councilor up to becoming a two (2)-termer Vice Mayor of the alluring island of IGACOS.

The visit aims to strengthen the cooperation and collaboration between the Provincial Government of Davao del Norte and the government forces in maintaining peace and order in the province.

commanders presented a Both brief background and situational report, particularly the current operational brigades. According to COL Babac, his

area of responsibility in Davao del Norte, as Brigade Commander of 1001st Infantry Batallion, covers the municipalities of New Corella, San Isidro, Kapalong and Asuncion, including the City of Tagum, with a total land area of around one point seven (1.7) square kilometers with a population of around - over five hundred thousand (500,000), and also covers the four (4) municipalities of Agusan del Sur, Veruela, Loreto, La Paz and Santa Josefa, while the 1003rd Infantry Brigade lead by Brigade Commander COL Marion T. Angcao, covers the second and third district of Davao City and four (4) Municipalities of Davao del Norte namely; Santo Tomas, Braulio E. Dujali, Carmen, Talaingod and the City of Panabo, and sixteen (16) barangays in Bukidnon, composing of eight (8) barangays in Kitaotao and eight barangays of San Fernando with an estimated total area of five thousand (5,000) square kilometers.

Some updates of the situation of peace and order in the province were also tackled and the continuous initiative programs, resolutions and efforts of preventing crimes and maintaining a peaceful atmosphere in Davao del Norte. The two (2) Commanders further discussed the current security landscape, counterinsurgency campaign, interventions, accomplishments and sustainment efforts, especially that the province was recently declared insurgencyfree. At present they monitored zero NPA (New People's Army) activity and practically have a peaceful province since then. Also, they are conducting sustainment operations to ensure that the loss mass base including the former members and the so-called Underground Mass Organization (UGMO) will not be able to be recruited again.

Likewise, they gave input about activities and programs of their present the status of the people's organization and updates on former rebels who left

communist movement and decided to surrender and return to the folds of law. In coordination with the Local Government Units (LGUs) and Local Government Agencies (LGAs) these POs were given a livelihood of their choice and constantly being supervised and mentored by the Community Defense Teams (CDTs) composed of soldiers specifically organized and equipped with skills and knowledge to handle the POs. Further, he said that they will continue to conduct aggressive combat operations or visibility operations to preempt and prevent Communist Terrorist Group and to sustain the confidence of the residents in the far-flung areas and to continue the implementation of peace-building initiatives programs in order to protect and maintain Davao del Norte as insurgencyfree

In response, the SP of Davao del Norte headed by Vice Governor, Hon. De Carlo "Oyo" L. Uy, expressed their appreciation and gratitude for the sacrifices and efforts of all the men and women in uniform which significantly contributed to a peaceful and more progressive province. They also affirmed that the Local Government will support and commit for the implementation of the programs and initiatives of the AFP for the general welfare of the constituents of Davao del Norte. 🛓


