HIGHLIGHTS OF VICE GOVERNOR UY'S LEGISLATION-AND-BEYOND LEADERSHIP By: Iris P. Temperatura



From his assumption of office as of the education sector during the new the Head of Legislative Department on the noon of June 30, 2019 until now, "Legislation and Beyond" has been the centerpiece and anthem of Vice Governor Rey T. Uy's leadership. Aside from the legislative, quasi-judicial and oversight functions of the law-making body of the province, Vice Governor Uy initiated many laudable programs and projects for the Dabaonon people during his three stellar years, especially in the turmoils of the pandemic Coronavirus Disease 2019 (CoViD-19).

One of the notable beyond-legislation ingenuities of Vice Governor Uy during the pandemic time is when he and all the Sangguniang Panlalawigan Members personally went out from their offices and visited the barangay frontliners detailed in every COVID-19 checkpoints in the entire province to donate packed grocery items, notwithstanding the perils of the

normal where the learning method shifted to online teaching and modular based instruction, Vice Governor Uy distributed a number of computer printers to public schools throughout the province as support and response to the province's Basic Education Learning Continuity Plan. Disinfectant sprays, liquid soaps, alcohols, quality face masks, face shields and other health essentials were also handed to the public-school teachers for more efficient and effective implementation of sanitary practices in maintaining the health safety protocols set by the Inter-Agency Task Force (IATF). Meanwhile, during the flooding brought about by Bagyong Odette in some of the flood-prone areas of the province, affected families received not only packs of relief goods but also healthy packed meal as well.

The Sangguniang Panlalawigan for Term 2019-2022 has passed Three Thousand Six Hundred One (3,601) resolutions and Fifty-Six (56) ordinances from July 1, 2019 to June 30,2022.

in monitoring the implementation of various government projects and programs in Davao del Norte; (4) the "Switch On: Electrification sa mga Sitio" Project, through the Northern Davao Electric Cooperative (NORDECO) and in collaboration with CEO De Carlo "Oyo" Uy of Davao Metro Shuttle and Metro Gear Construction, which aims that have never been energized before and it was piloted in the sitios of Asuncion, New Corella and Talaingod; (5) Shelter Assistance Program, in partnership again with the Metro Gear Construction Corporation headed by CEO Oyo L. Uy, which aims to provide respectable homes to families within the province; (6) gravelling of over sixty-five (65) roads and provision

participation and volunteers' mobilization of construction materials to ninety-five (95) beneficiaries across the Province of Davao del Norte; (7) the implementation of "Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced (TUPAD) Program, in partnership with TINGOG Partylist, TURISMO Partylist and Department of Labor and Employment (DOLE), which aims to assist and support to deliver electric power to communities the livelihood of workers who lost jobs during the global pandemic; (8) Assistance to Individuals in Crisis Situation (AICS), which has similar objectives to the TUPAD Program; (9) distribution of assistive devices to the differently-abled constituents of Davao del Norte such as wheelchairs, canes, quad canes, and walkers; and many more Aksyon-Agad services to the public.


