
The Community-based Education for Economic Opportunities (CEE-O Star) conducted six graduations for the Municipality of Asuncion, particularly at Barangays Doña Andrea, New Bantayan, Cambanogoy, Canatan, Sagayen and Sta. Filomena, with the total of 538 graduates attended the graduation ceremony. These graduates were given free learning sessions for four days and were provided with educational kits that they can use even after their lessons. For Vice Governor Rey T. Uy, "it is a great avenue to help our small and young entrepreneurs all over the province to make their businesses ventures long lasting and to establish good foundation in manning an industry."

Another breakthrough that Vice Governor Uy has accomplished was his visit to the twenty-three (23) barangays of the City of Tagum. SERBISYONG OKEY PADAYON NGA GIHATOD SA KATAWHAN NI BM TETE SO

Bisan sa padayon nga hulga sa COVID-19 sa mga nilabay nga bulan sa tuig 2021, padayon ang pag-alagad ug pagpanerbisyo ni Senior Board Member Robert "Tete" So sa sulod ug gawas sa iyang buhatan sa Kapitolyo. Wala nakapugong ang maong makamatay nga sakit aron mahatod ang serbisyo nga haom ug gikinahanglan sa katawhan sa Distrito Uno. Kini nagapamatood nga ang Serbisyong Okey ni BM Tete So anaa ug andam mamati sa mga panginahanglanon sa katilingbang Dabaonon.

Isip usa ka magbabalaod sa Probinsya, padayon nga gituman ni BM Tete So ang iyang mga mandato sa usa ka elected public official sa legislative department. Sa pagpanguna niya sa komitiba sa Finance, Budget and Appropriations, giduso ni BM Tete So ang nagkadaiyang balaodnon sa konseho alang sa katawhan nga adunay kalambigan sa panudlanan sa Davao del Norte. Usa sa iyang giduso ang pag-aprobar sa Supplemental Budget No. 2 (SB #2) sa kasamtangang

tuig nga nagkantidad ug Sixty Six Million, Seven Hundred Twelve Thousand, Seven Hundred Forty-Five Pesos ug 33/100 centavos. Gituki ni BM Tete So kung haom ba ang pag-allocate sa mga pondo sa Probinsya sa mga nagkadaiyang panginahanglanon sa Davao del Norte, hilabina sa atong nahiaguman nga pandemya. Gisuta ni BM Tete So sa SB #2 kung dili ba maapektohan ang kasamtangan operasyon satulo(3) ka district hospitals (DH) nga iya sa Probinsya – Kapalong DH, Carmen DH ug Samal DH – nga diin nahimong mga isolation facilities sa mga nagpositibo sa COVID-19. Nahibaw-an nga adunay mga savings gikan sa mga bakanteng posisyon nga maoy gihimong "source of funds" niin. "Ang akong concern man gud pag muiungan ta'g unfilled positions labi na karon sa pandemic, hospital is isa sa mga pinakaimportanteng butang. Wala ba kaha naapektuhan ang atong operation didto?", ang pagtuki ni BM Tete So sa mga resource persons atol sa question hour sa plenaryo. Gibutay ug gipasalig ni Provincial Administrator,

Engr. Josie Jean R. Rabanoz, nga majority sa mga unfilled positions nga source of fund sa SB #2 gikan sa laing departamento sa Probinsya ug gamay lang gikan sa mga District Hospitals. Sa laing bahin, dugang nga gituki sa dinihi ang nahimong kakulangon sa medical-grade oxygen sa mga hospitals sa Probinsya. Mahinumdoman nga nag headlines ang kakulangon niini tungod sa pagsaka sa mga nagpositibo sa COVID-19 tungod sa gikahadlokan nga delta variant. "May we know if there is an amount allocated for oxygen?", pangutana ni BM Tete So. Sa pagsusi, adunay dugang gigahin nga P2 milyon ang Probinsya sa SB #2 para sa maong concern. Kani nga pondo alalay sa nauna nga 5,000 ka oxygen tanks nga gipalit sa Probinsya, pinaagi sa Provincial Health Office, isip panagang sa hulga sa kakulangon sa medical oxygen. Ang maong oxygen tanks gigahin sa 3 ka DHs para sa mga pasyente nga naglisud ug ginhawa. Hinoon, anaa pa ang Calamity Fund

nga pwede magamit sa Probinsya kung ugaling kulangon pa ang maong pondo. Nasuta usab nga naggahin ug laing kantidad ang Probinsya ilalom sa SB #2 para sa mga tambal reseta sa mga pasyente sa DHs. Gikalipay ni BM Tete So nga gigahinan gyud ug dugang nga pondo sa Probinsya alang sa pagpalit ug oxygen ug tambal nga gikinahanglan hilabina sa mga kabos nga pasyente. Dugang nga gikalipay ni BM Tete So nga gidungagan ang pondo alang sa pauper's burial assistance sa Provincial Social Welfare and Development Office (PSWDO) alang sa paghatag ug bugas ug cash assistance sa mga kabos nga namatyan ug kapamilya. Kini ug lain pang pag-allocate ug pondo ilalom sa SB #2 nagapamatood nga ang giduso sa komitiba ni BM Tete So ang kaayohan sa mga nanginahanglang Dabaanon. Uban sa iyang mga kauban sa konseho, gi-aprobahan sa 3rd and Final Reading ang maong

balaodnon niadtong Setyembre 20, 2021 atol sa ika-38th Regular Session aron dili ma delay ang paghatod sa tabang ngadto sa katawhan.

Sa laing mga inisyatibo ni BM Tete So, naghatod ang iyang buhatan sa nagkadiiyang tabang ngadto sa katawhan sa Davao del Norte. Gilibot ug natagaan na ang 93 ka barangays sa Distrito Uno ug tactical flashlights nga dako ug gamit sa kagabhiion hilabina sa panahon sa adunay calamidad ug rescue operations. Ang maong tactical flashlights gi apod-apod matag barangay aron magamit sa mga barangay functionaries sa pagmintinar sa kalinaw ug kahapsay sa barangay. "Dako kayo ni'g tabang sa amo a BPATS sa among pag roving matag gabii", butyag sa usa ka barangay functionary tungod kay nadungagan ang katakos sa ilang komunidad aron sa mas maayong pagpanerbisyo sa mga lumulupyo.

Ug wala nakapugong ang pandemya ni BM Tete So aron masuportahan ang mga magtutudlo

ug ginikanan sa Brigada Eskwela 2021. Naghatod ug pintura, monoblock chairs, bond paper, ug face masks, ug uban pa sa mga tulonghaan sa elementary ug sekondarya sa Distrito Uno. Kini usa sa mga prayoridad ni BM Tete So aron maka-angkon ug maayong edukasyon ang mga kabatan-onan nga mamahimong dalan sa pagkabot sa ilang mga tinguha sa kinabuhi. Wala usab giundang ni BM Tete So ang iyang programang palugaw nga nagalibot-libot sa kadalan sa Distrito Uno. Nagatuo si BM Tete nga bisan lugaw lang kini, apan makatabang gihapon sa katawhan. Nag apod-apod usab ug face mask ang buhaton ni BM Tete sa kapurokan aron malikayan ang pagkuyanap sa COVID-19.

Pakusgan pa sa buhatan ni BM Tete So ang mga tabang nga ipaabot ngadto sa kabbarangay ug kapurokan sa mga musunod nga bulan. Nagatuo si BM nga bisan sa pandemya, ang pagpanerbisyo angay nga anaa.


