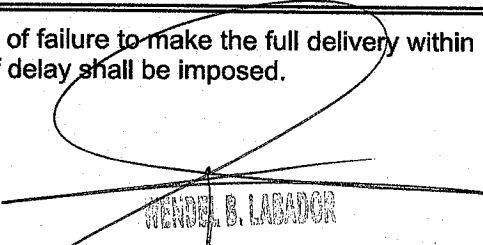

The procuring entity shall be allowed to make adjustments in the units/volume to be delivered per type of product to conform to the remaining amount in the total contract price.
- The supplier shall be responsible to dispense fuel to **PEO - Engineering and Infrastructures** vehicles only and ensure that issued fuel will not exceed PO allocation.

9. No advance withdrawal is allowed prior to the approval of the Purchase Order.

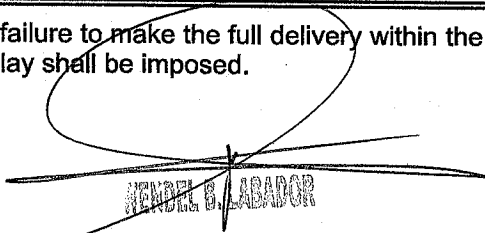
10. Additional fund allocation due to supplemental budget, augmentation shall follow the usual procedures of procurement.

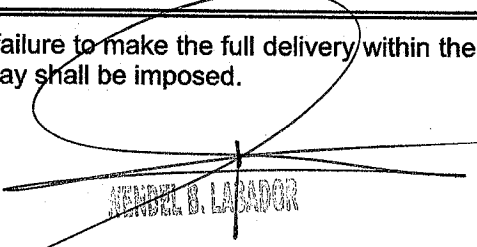
